### **Jurong Port Pte Ltd - Demerit Points Scheme (DPS)**

Pursuant to Rules 90A and 90C (Section 14A) of the General Rules and Regulations for Jurong Port, Jurong Port Private Limited (JPPL) has implemented a Demerit Points Scheme (DP Scheme) which is applicable to all Port Users entering Jurong Port.

Every Port User must comply with the DP Scheme and ensure compliance by its employees, agents, contractors, temporary workers and all other persons who enter Jurong Port.

It is in JPPL's sole discretion to decide whether any Port User has complied with the DP Scheme and to decide how to apply the DP Scheme, including exercising JPPL's right to suspend and/or terminate any license, pass or permit as may be issued by JPPL.

Nothing in the DP Scheme is intended nor should be taken as absolving or reducing the duties, obligations and responsibilities of the Port User to take all measures to ensure the safety, health and security of themselves and other persons and the safety and security of the property of themselves or others.

Non-compliance with the DP Scheme will be viewed seriously and JPPL is entitled to impose the sanctions stated in the infringement index below and as amended from time to time, or any other sanction as JPPL may deem fit in the circumstances.

## 1 Demerit Point Scheme

1.1 The DPS consists of rules which fall under the following categories:

- a) Safety (including health and environment);
- b) Security;
- c) Traffic;
- d) Operation;
- e) Human Resource (HR) (including those requirements for work permit and labour law)

1.2 Any infringement committed by port user, the offender will be penalised according to the classification of offence table shown below.

## 2 Disciplinary Actions

- 2.1 Offender is only allowed to accumulate up to **24** demerit points. The duration for retaining the demerit points will be indefinite.
- 2.2 Once the stipulated demerit points are accumulated, offender will be liable for suspension according to the table below:


Accumulation of stipulated points within <b>36</b> months	Disciplinary Actions
1 <sup>st</sup> Occurrence	Minimum 1-month suspension followed by 2 months' probation
2 <sup>nd</sup> Occurrence	Minimum 1-month suspension followed by 2 months' probation
3 <sup>rd</sup> Occurrence	Debarment / revocation of license / pass.

- 2.3 During suspension, the offender is required to develop and submit corrective action plans to the satisfaction of JPPL. Corrective action plans shall be implemented during their probation period.

- 2.4 Any infringement(s) during the probation period, the offender will be suspended for 1 month.
- 2.5 After completion of suspension, the offender’s demerit points will be reset to zero and the revised limit for demerit points will be reduced from **24** to **12** for a period of **1** year.
- 2.6 In recognition of good performance made by offender, demerit points accumulated will be deducted based on the duration of clean slate period shown below.

1 <sup>st</sup> block of 4 months	2 Demerit Points
2 <sup>nd</sup> block of 4 months	3 Demerit Points

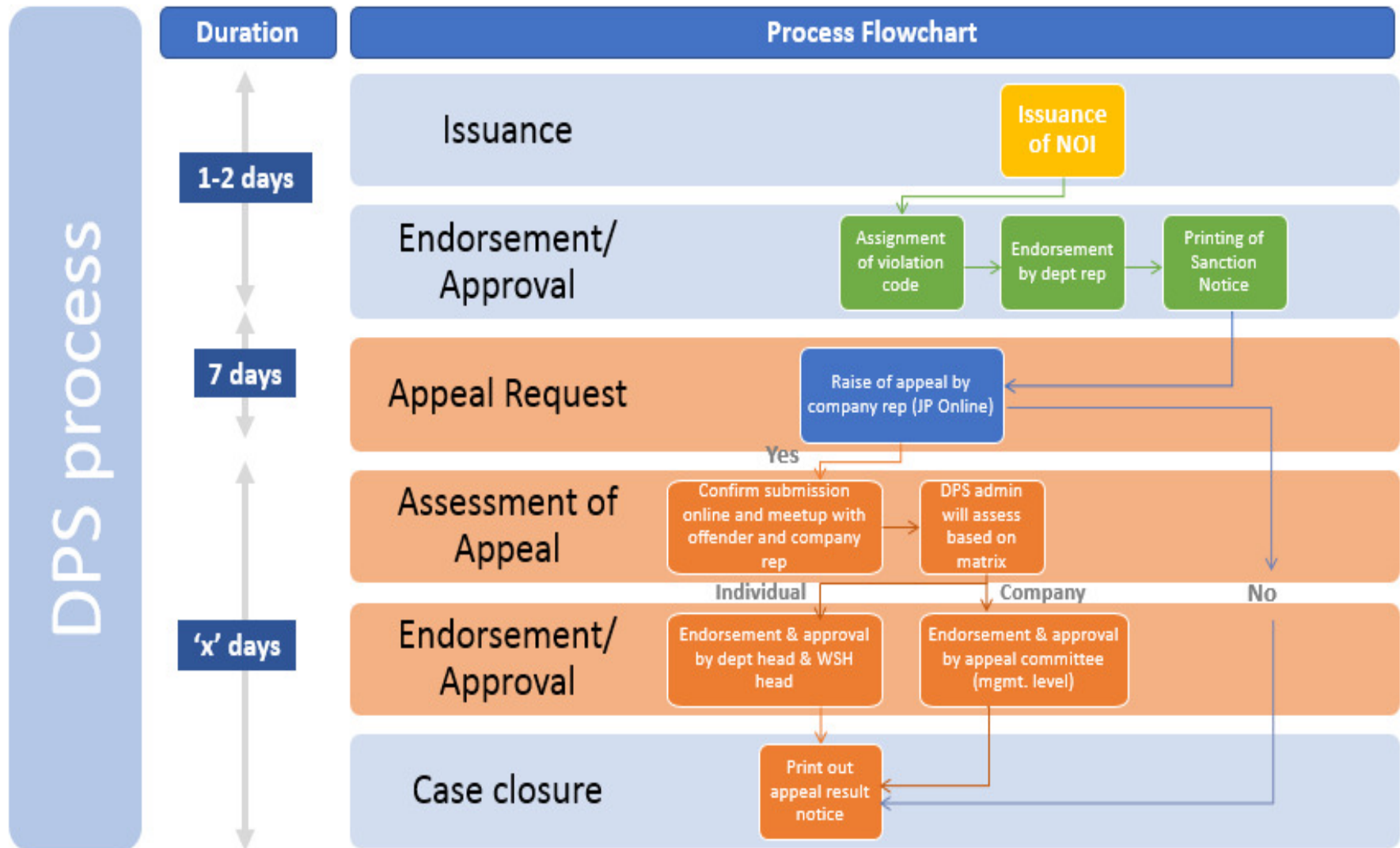
- 2.7 The demerit points of the offender will continue to expunge until it becomes **zero**.
- 2.8 Jurong Port Pte Ltd reserves the right to take further action, not excluding a permanent debarment against the offender / company, if the enforcement charge(s) is not paid within stipulated period.
- 2.9 Upon receipt of Sanction Notice; offender shall either:
- a) Proceed to pay the enforcement charge with the notice at Jurong Port Pass Office Building within 7 working days (from date of Notice);
- OR**
- b) Lodge an appeal online against the infringement within 7 working days (from date of Notice through company management representative).
- 2.10 If the offender does not take any actions stated above within 7 working days period, offender will be suspended temporarily until the necessary actions has been carried out
