**RELOCATION OF LIGHTER/OPL ACTIVITIES FROM PASIR PANJANG LIGHTER WHARVES (PPLW) TO PENJURU TERMINAL (PT)**

1. The Lighter/OPL activities at Pasir Panjang Lighter Wharves will be relocated to Penjuru Terminal located at 42G, Penjuru Road, Singapore 609151. Please see Appendix 1 for location of Penjuru Terminal.
2. Penjuru Terminal is operated by Jurong Port Pte Ltd.
3. The relocation of the crane operations will be staggered over three days to minimize inconvenience to the users. The dates of the relocation are as follows:

4. Lighter/OPL operators and ship chandlers are advised to liaise with their respective mobile crane companies on operations details.


