# **Unapproved Minor Addition/ Alteration Works**

JP's Workplace, Safety & Health (WSH) department have conducted several Arson Prevention Inspections at various locations such as tenanted warehouses, offices and leased areas. For the 2<sup>nd</sup> Quarter of WY17, more focus was given to the above said matter. Common findings so far are as per below.

Unapproved Minor Addition/ Alteration works (Erected partitions)



## What are 'Minor Addition/ Alteration Works'?

Minor Addition/ Alteration Works or also known as 'Minor A & A works' refers to the erection or deletion of internal partitions (including alteration to fire protection system). The erection of internal partitions should only involve materials of lightweight non-combustible construction and must not affect the fire compartmentation and means of escape provisions, or pose additional fire hazard to the building.

## **Corrective Actions**

Such works are to be carried out in a proper procedure by Qualified Professionals (QP) before such structure is deemed approved for use. Submission of plans can be done by the following QPs:

- Registered architect; or <u>http://www.boa.gov.sg/register.html;</u>
- Professional Engineer (Civil); or <u>https://www.peb.gov.sg/pe\_general\_pe.aspx</u>
- Professional Engineer (Structure); or
- Professional Engineer (Mechanical); or
- Professional Engineer (Electrical).

Upon approval, a Fire Safety Certificate will be issued by SCDF for retention.
