TEMPORARY WAITING AREA FOR MARINA SOUTH WHARVES (MSW) SHIP SUPPLIERS' TRUCKS – PILOT TRIAL JAN'25

LT Connect, a digital collaborative platform launched by Jurong Port for all lighter terminal users, provides visibility by connecting all stakeholders in the lighterage supply chain via one singular platform. This facilitates Just-In-Time operations through the adoption of digital technology to match truck and lighter boat arrivals at the two Jurong Port Lighter Terminals – Marina South Wharves and Penjuru Lighter Terminal.

We remind all lighter terminal users to use LT Connect for effective pre-planning, coordination, and timely arrival at the Lighter Terminals for ship supply operations.

In view of traffic condition at Marina Coastal Drive, we will be conducting a pilot trial with a temporary waiting area for ship suppliers' delivery trucks. During the mentioned period, please proceed to the following temporary waiting area situated **along Marina South Drive towards Marina Gardens Drive, between lamppost 16F to 10F**, subject to availability. The temporary waiting area will be available on the following period, which will coincide with Marina Bay Cruise Centre's double cruise ships calls:

Date	Time
12 January 2025	0730hrs to 1500hrs
14 January 2025	0630hrs to 1200hrs
27 January 2025	0730hrs to 1200hrs

Please note the following requirements at the temporary waiting area:

1. Vehicles should be parked as close to the edge of the road as possible so that no obstruction is posed to the traffic.
2. There should be strictly **NO PARKING**:
 - a. At road bends and entrances or exits of any other premises or car parks;
 - b. Within 3 meters of a fire hydrant, 6 meters of a road junction, 9 meters of a bus stop and at all designated pedestrian crossings;
 - c. Opposite double white lines or parking abreast to another vehicle;
 - d. On the grass verge and footway; and
 - e. Vehicles must also be parked parallel with the road kerb and in the direction of the traffic flow.
3. Please note that the relevant Authority would not hesitate to take summon action against any vehicles found parking indiscriminately, contravening any of the above conditions or parking outside the above-mentioned date or timing.
