MANDATORY CARGO SCREENING AT ICA JURONG SCANNING STATION

Reference: Jurong Port Circular No. 69 of 2020 (Annex A)

1. This circular serves as a formal reminder to all port users. Prime movers with mounted containers **MUST** proceed to the ICA Jurong Scanning Station for mandatory cargo screening when their Truck Instruction Document (TID) explicitly indicates "SCAN REQUIRED: JP" (See Annex B for sample).
2. Non-compliance will result in penalties and regulatory action. Any driver who fails to comply will be issued a Notice of Infringement (NOI) with the following consequences:

Description	Individual Demerit Point	Fine
Failure to complete the mandatory cargo screening requirement by ICA	6	\$100
Repeatedly failing to complete the mandatory cargo screening requirement by ICA	12	\$200

3. Driver and the company involved will also be subject to further action and penalties by regulatory authorities.

With effect from 15 Oct 2020, all prime movers with mounted containers exiting Jurong Port West Gate (JPWG) are reminded that it is a **MUST** proceed to the ICA Jurong Scanning Station for cargo screening.

Prime movers without mounted containers are **NOT** required to go for cargo screening.

Please be advised that any drivers who fail to comply with this requirement will be issued with the following Notice Of Infringement (NOI):

Description	Individual Demerit point	Fine
Failure to complete the mandatory cargo screening requirement by ICA	6	\$100
Repeatedly failing to complete the mandatory cargo screening requirement by ICA	12	\$200
