- 2.1 Overside Barge(s) will only be allowed to move to the Parking Area if the "Mother-Ship" is required to berth/unberth after daylight hours or to accommodate another barge.
- 2.2 MPA and Jurong Port Duty Officer must be informed before proceeding into and leaving the Parking Area.
- 2.3 The barge & tug must be sufficiently manned at all times for appropriate action to be taken in case of emergency.
- 2.4 MPA must be informed immediately by VHF Channel 25 in the event of any emergency affecting the safety of life or vessel and to comply with all instruction which the MPA Controller may issue in respect thereof.
- 2.5 The Owner, Agents or Master shall meet in full all liabilities in connection with any service or assistance provided by Jurong Port Pte. Ltd. or other Authorities.
- 2.6 Dockage charge at S\$10.00 per hour is applicable (Berthing/unberthing & LOA in excess of 100m will be charged as per Jurong Port tariff)
- 2.7 Jurong Port Pte Ltd reserves the right to impose overstay dockage if the barge(s) fail to leave the Parking Area after daylight 0630 hrs.
- 2.8 For movement of the barge to and from the Parking Area to the "Mother-Ship" or vice-versa, at least two tugs are required to be in attendance; one of them is to be a harbour (ST) tug.
