TERMS AND CONDITIONS OF HIRE

1. The Hirer shall have notice of and shall accept and comply with all rules and regulations including but not limited to the General Rules and Regulations of Jurong Port Pte Ltd ("Jurong Port") which is presently in force and available at <http://www.jp.com.sg> including any amendments, modifications and additions which may be incorporated from time to time.
2. The Hirer shall:
  - a. Only use the MHC within the areas specified in Jurong Port's premises;
  - b. Comply with all safety and operational requirements and shall exercise due care and skill, in the use and operation of the MHC;
  - c. All safety and operational rules and regulations and procedures are duly notified to the relevant or related personnel or parties involved or engaged in the operation.
  - d. Comply with all statutory and statutory requirements during its operations, in particular those required by the Ministry of Manpower, including the provision of properly qualified and certified lifting crew (such as lifting supervisor, rigger man, and signal man) and lifting gears;
  - e. All the forms and 5 certificates are duly submitted to JP and endorsed by JP port engineering before start of operations.
  - f. Supply all necessary equipment, for the safe and proper execution of operations including but not limited to wire slings, spreader bars, shackles and other accessories, which are certified by professional engineers and approved by relevant authorities;
  - g. Ensure that there is sufficient and suitable particular for 3<sup>rd</sup> party liability and public liability, in respect of the operations; and
  - h. Not employ the MHC to handle cargo gross weight (including all lifting gears shall not exceed 77 metric tonnes under the hook of MHC.
  - i. If the actual cargo weight is found to exceed the cargo lifting weight as declared, penalty charges shall be levied on the cargo as follows: understated weight between 1 to 5 tonnes - \$500/unit; understated weight > 5 tonnes - \$1,500/unit. Jurong Port reserves the right to suspend and cancel the heavy lifting job. In this instance, a cancellation fee equivalent to 20% of the minimum charge will be imposed.
3. In the event of a breach of any of the terms herein, Jurong Port shall at its sole and absolute discretion, be entitled to suspend or terminate the hire of the MHC, impose any further terms and conditions or be indemnified for any costs incurred to rectify any of the said breaches.
4. Notwithstanding the generality of the foregoing, the MHC shall remain under the full control, direction and supervision of the Hirer and shall release Jurong Port from any liability whatsoever from use and operation of the MHC. JPPL shall not liable for any loss, damage, action, demand, proceeding claim, cost and expenses due to breakdown failure or malfunction of the MHC. The Hirer shall also indemnify Jurong Port against any liability arising from the custody, use and operation of the MHC unless such liability arises fully from the negligence or willful default of Jurong Port's staff.
